#### 3. Informational updates

a. NYPD - 23rd Precinct has seen increase in violence that has been stemming from local teen, gang violence from rival gangs in many of the NYCHA Houses here in East Harlem, particularly from the Washington and Carver Houses. There is an

ongoing investigation for two murders in the district in which, due to the investigation being ongoing, details cannot be shared. Despite these setbacks, crime has dropped 6.1% this year.

- b. NYPD- 25<sup>th</sup> Precinct reported that there have been no homicides, however he reported that there has been an increase in crimes resulting from rapes and domestic violence.

- a. Pitta Bishop & Del Giorno LLC

The firm came to present on a signage change to create a part-time truck loading zone on the southwest corner of 1st Avenue and 103rd St for the new C-Town Supermarket. They will return next month to seek a letter of support.
