# 2. Informational Updates:

-Xavier Santiago participated in a CB11 walk-through of Taft Houses and discussed possible use of abandoned storefronts as resources to the residents.

-Angel Mescain and Nilsa Orama participated in an initial meeting on May 29, 2018 with Fortune Society to discuss Fortune Society's selection as a developer of three HPD sites on the north side of 124th St between Park and Lexington. Fortune Society is interested in replicating its project called "The Castle" on the west side in Community Board 9, which will entail a mix of half supportive housing and half permanently affordable housing.

-The Rent Guidelines Board is holding public hearings around the city regarding its annual determination of rent increase percentages for rent-stabilized renewal leases

a. FY 2020 Statement of District Needs & Budget Priorities: The committee briefly reviewed the Statement of District Needs and Budget Priorities for FY 2019 and determined that it would set dates in the near future to begin work editing the document for FY 2020.
