I, Hector Cruz, as a qualified representative of American Grill Inc,
located at 1798 3rd Ave, New York, NY agree to the following stipulations:

1. I will operate a full-service restaurant, specifically a (type of restaurant) _____, with a kitchen open and serving food during all hours of operation OR have less than full-service kitchen but will serve food all hours of operation OR Other _____
2. My hours of operation will be Monday thru Friday 8:30am-8:00pm
Saturday 9-5pm Sunday 10am-5pm
(I understand opening is "no later than" specified opening hour, and all patrons are to be cleared from business at specified closing hour.)
3. I will not use outdoor space for commercial use OR 4. I will operate my sidewalk café no later than _____
5. I will employ a doorman/security personnel on the following days: _____

13. I will not have unlimited drink specials, including boozy brunches, with food.
